Summary (as of Sep 29, 2015)

Mental Health Awareness Semipostal Stamp Act

This bill directs the United States Postal Service to issue and sell, at a premium, a Mental Health Awareness Semipostal Stamp. Use of this stamp must be voluntary for postal patrons.

Proceeds from the sale of this stamp must be transferred to the National Institute of Mental Health to help fund mental illness research and suicide prevention programs.

The stamp must be available to the public for at least six years.

Actions Timeline

- **Oct 2, 2015:** Referred to the Subcommittee on Health.
- **Sep 29, 2015:** Introduced in House
- **Sep 29, 2015:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
