## Summary (as of Apr 16, 2015)

Recognizes the hardships that people with disabilities must overcome every day.

Reaffirms support of the Architectural Barriers Act of 1968 and the Americans with Disabilities Act of 1990.

Recommends that the United States Postal Service and federal agencies install power-assisted doors at post offices and other federally funded facilities to ensure equal access for all people.

Pledges to continue to identify and remove the barriers that prevent equal access to federal government services.

## Actions Timeline

- **May 15, 2015:** Referred to the Subcommittee on the Constitution and Civil Justice.
- **Apr 17, 2015:** Referred to the Subcommittee on Economic Development, Public Buildings and Emergency Management.
- **Apr 17, 2015:** Referred to the Subcommittee on Health.
- **Apr 16, 2015:** Introduced in House
- **Apr 16, 2015:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committees on Education and the Workforce, the Judiciary, Energy and Commerce, and Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
