Summary (as of Jan 22, 2015)

Expresses support for efforts to:

- ensure that women have access to the best available health care and information, including comprehensive, affordable insurance coverage and health care that fosters safe childbearing;
- ensure that women can make their own health care decisions;
- prohibit employers or government entities from interfering with reproductive health care services guaranteed by law; and
- guarantee the constitutionally protected right to safe, legal abortions.
