First Responders Passport Act of 2015

(Sec. 2) This bill amends the Passport Act of June 4, 1920 to waive passport fees for an individual who is operating under a contract, grant, or cooperative agreement with the U.S. government, including a volunteer, to aid a foreign country suffering from a qualifying natural disaster.

The Department of State shall report to Congress on the number of fee waivers for the issuance of passports to first responders.

Actions Timeline

- **Feb 1, 2016:** Star Print ordered on the bill.
- **Dec 17, 2015:** Received in the Senate and Read twice and referred to the Committee on Foreign Relations.
- **Dec 16, 2015:** Mr. Royce moved to suspend the rules and pass the bill, as amended.
- **Dec 16, 2015:** Considered under suspension of the rules. (consideration: CR H9346-9348)
- **Dec 16, 2015:** DEBATE - The House proceeded with forty minutes of debate on H.R. 3750.
- **Dec 16, 2015:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
