Summary (as of Nov 4, 2015)

West Coast Ocean Protection Act of 2015

This bill amends the Outer Continental Shelf Lands Act to prohibit the Department of the Interior from issuing a lease for the exploration, development, or production of oil or natural gas in any area of the outer Continental Shelf off the coast of California, Oregon, or Washington.
