Summary (as of Nov 16, 2015)

This bill amends the Moving Ahead for Progress in the 21st Century Act (MAP-21) to require that at least 10% of the funds made available for federal-aid highways and highway safety construction programs, including highway safety research and development, and for the Federal Public Transportation Act of 2012 be expended through small business concerns owned and controlled by veterans.

Actions Timeline

- Nov 17, 2015: Referred to the Subcommittee on Highways and Transit.
- Nov 16, 2015: Introduced in House
- Nov 16, 2015: Referred to the Committee on Transportation and Infrastructure, and in addition to the Committee on Small Business, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
