## Summary (as of Dec 16, 2015)

### Medicare Advantage Quality Payment Relief Act of 2015

This bill amends title XVIII (Medicare) of the Social Security Act to require the Centers for Medicare & Medicaid to disregard the application of certain percentage quality increases when calculating the maximum payment that may be made to a Medicare Advantage organization.

## Actions Timeline

- **Dec 18, 2015:** Referred to the Subcommittee on Health.
- **Dec 16, 2015:** Introduced in House
- **Dec 16, 2015:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Dec 16, 2015:** Referred to the Subcommittee on Health.
