Unifying Small Business Terminology Act of 2016

(Sec. 2) This bill amends the Small Business Act to revise the range of the anticipated value of federal procurement contracts that must be reserved exclusively for small businesses.

The range shall be between the micro-purchase threshold (\$3,000) and the simplified acquisition threshold (\$100,000). (Currently the range of the anticipated value must be between \$2,500 and \$100,000.)

Actions Timeline

- **Apr 20, 2016:** Received in the Senate and Read twice and referred to the Committee on Small Business and Entrepreneurship.
- **Apr 19, 2016:** Mr. Chabot moved to suspend the rules and pass the bill.
- **Apr 19, 2016:** Considered under suspension of the rules. (consideration: CR H1834-1835)
- **Apr 19, 2016:** DEBATE - The House proceeded with forty minutes of debate on H.R. 4325.
- **Apr 19, 2016:** Passed/agreed to in House: On motion to suspend the rules and pass the bill Agreed to by voice vote.(text: CR H1834)
- **Apr 19, 2016:** On motion to suspend the rules and pass the bill Agreed to by voice vote. (text: CR H1834)
- **Apr 19, 2016:** Motion to reconsider laid on the table Agreed to without objection.
- **Jan 6, 2016:** Introduced in House
- **Jan 6, 2016:** Referred to the House Committee on Small Business.
