Summary (as of Jan 8, 2016)

This bill expresses the sense of Congress that the President should revoke the Presidential Medal of Freedom awarded to William Henry (Bill) Cosby in 2002.

Additionally, it amends the federal criminal code to make it a crime to fraudulently wear or publicly display a Presidential Medal of Freedom that has been revoked. A violator is subject to a fine, up to one year in prison, or both.

Actions Timeline

- **Feb 3, 2016:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations.
- **Jan 8, 2016:** Introduced in House
- **Jan 8, 2016:** Referred to the Committee on the Judiciary, and in addition to the Committee on Oversight and Government Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
