This bill authorizes funds made available in prior appropriation Acts to any federal agency for Ebola response and preparedness to be used for Zika virus response and preparedness.

- **Feb 3, 2016:** Sponsor introductory remarks on measure. (CR H507)
- **Feb 3, 2016:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Foreign Affairs, and Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
