Summary (as of Feb 25, 2016)

CT Colonography Screening for Colorectal Cancer Act of 2016

This bill amends title XVIII (Medicare) of the Social Security Act to: (1) provide Medicare coverage for screening computed tomography colonography (CTC) as a colorectal cancer screening test, and (2) exclude screening CTC from a special Medicare payment rule applicable to certain imaging services.

Actions Timeline

- **Mar 2, 2016:** Referred to the Subcommittee on Health.
- **Feb 26, 2016:** Referred to the Subcommittee on Health.
- **Feb 25, 2016:** Introduced in House
- **Feb 25, 2016:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
