Summary (as of Mar 1, 2016)

Promoting Travel, Commerce, and National Security Act of 2016

This bill amends the federal criminal code to allow the United States to prosecute certain U.S. employees who engage in conduct in Canada that would constitute a federal criminal offense if the conduct had occurred in the United States. This bill applies to employees, contractors, and grantees of a U.S. department or agency other than the Department of Defense who are stationed in Canada pursuant to a border security initiative.

Actions Timeline

- **Apr 1, 2016:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations.
- **Mar 1, 2016:** Introduced in House
- **Mar 1, 2016:** Referred to the House Committee on the Judiciary.
