CBD Oil Act of 2016

This bill amends the Controlled Substances Act to bar the federal prosecution of an individual who produces, distributes, or uses CBD oil for medical research or medical purposes in compliance with state law.

The term "CBD oil" means a marijuana extract that is composed of a nonpsychoactive proportion of tetrahydrocannabinol and cannabidiol under state law.

Actions Timeline

- **Apr 1, 2016:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations.
- **Mar 18, 2016:** Referred to the Subcommittee on Health.
- **Mar 17, 2016:** Introduced in House
- **Mar 17, 2016:** Referred to the Committee on the Judiciary, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
