Sets forth the rule for consideration of the bill (H.R. 1090) to amend the Securities Exchange Act of 1934 to provide protections for retail customers.

Actions Timeline

- **Oct 27, 2015:** Considered as privileged matter. (consideration: CR H7201-7207)
- **Oct 27, 2015:** DEBATE - The House proceeded with one hour of debate on H. Res. 491.
- **Oct 27, 2015:** DEBATE - At the conclusion of debate on H. Res. 491 the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Polis demanded the yeas and nays and the Chair postponed further proceedings on the question until a time to be announced.

- **Oct 27, 2015:** On ordering the previous question Agreed to by the Yeas and Nays: 242 - 185 (Roll no. 570). (consideration: CR H7214-7215)
- **Oct 27, 2015:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 244 - 186 (Roll no. 571).(text: CR H7201)

- **Oct 27, 2015:** Motion to reconsider laid on the table Agreed to without objection.
- **Oct 26, 2015:** Introduced in House
- **Oct 26, 2015:** The House Committee on Rules reported an original measure, H. Rept. 114-313, by Mr. Collins (GA).
- **Oct 26, 2015:** An amendment in the nature of a substitute consisting of the text of Rules Committee Print 114-31 shall be considered as adopted. The further amendment printed in the report accompanying the resolution shall be considered as read, shall be debatable for 10 minutes, and shall not be subject to a demand for division of the question.
