Summary (as of Apr 13, 2016)

China Market Economy Status Congressional Review Act

This bill amends the Tariff Act of 1930 to bar revocation of a determination by the administering authority (the Secretary of Commerce or any other U.S. officer) that the People's Republic of China is a nonmarket economy country unless:

- the administering authority determines and reports to Congress that China no longer meets the requirements of a nonmarket economy country; and
- Congress, within 45 days after the receipt of such a report, enacts a joint resolution of approval.

Actions Timeline

- **Apr 22, 2016:** Referred to the Subcommittee on Trade.
- **Apr 13, 2016:** Introduced in House
- **Apr 13, 2016:** Referred to the Committee on Ways and Means, and in addition to the Committee on Rules, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
