Adopts the Rules of the House of Representatives for the 113th Congress as the Rules for the 114th Congress, with amendments.

Actions Timeline

- **Jan 6, 2015:** Considered as privileged matter. (consideration: CR H7-27)
- **Jan 6, 2015:** Ms. Norton moved to refer the resolution to a select committee of five members, to be appointed by the Speaker, not more than three of whom shall be from the same political party, with instructions not to report back the same until it has conducted a full and complete study of, and made a determination on, whether there is any reason to deny Delegates voting right in the Committee of the Whole House on the state of the Union.
- **Jan 6, 2015:** Mr. McCarthy moved to table the motion to refer
- **Jan 6, 2015:** On motion to table the motion to refer Agreed to by the Yeas and Nays: 230 - 160 (Roll no. 3).
- **Jan 6, 2015:** DEBATE - The House proceeded with one hour of debate on H. Res. 5.
- **Jan 6, 2015:** On ordering the previous question Agreed to by the Yeas and Nays: 239 - 168 (Roll no. 4). (consideration: CR H25)
