Summary (as of Apr 20, 2016)

Flexibility in Electronic Health Record Reporting Act

This bill requires the Department of Health and Human Services, with respect to electronic health record (EHR) meaningful use incentive programs under Medicare and Medicaid, to continue through 2016 to allow the use of quarterly reporting without regard to the payment year or the stage of meaningful use criteria involved.

Actions Timeline

- **Apr 22, 2016:** Referred to the Subcommittee on Health.
- **Apr 20, 2016:** Introduced in House
- **Apr 20, 2016:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
