Summary (as of Apr 29, 2016)

This bill prohibits the Department of Health and Human Services from taking any further action on a proposed rule to change how Medicare pays for certain drugs that are typically not self-administered (such as some intravenous medications and chemotherapy drugs).

Actions Timeline

- **May 12, 2016:** Referred to the Subcommittee on Health.
- **May 6, 2016:** Referred to the Subcommittee on Health.
- **Apr 29, 2016:** Introduced in House
- **Apr 29, 2016:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
