114 SRES 616	Identical bill	Nov 17, 2016: Referred to the Committee on Health, Education, Labor, and Pensions. (text of measure as introduced: CR S6488-6489)
114 SRES 282	Identical bill	Nov 18, 2015: Resolution agreed to in Senate without amendment and with a preamble by Unanimous Consent.

Expresses support for: (1) the goals and ideals of American Diabetes Month, including encouraging individuals to fight diabetes through public awareness about prevention and treatment options and enhancing education about the disease; and (2) decreasing the prevalence of type 1, type 2, and gestational diabetes in the United States through increased research, treatment, and prevention.

Recognizes the importance of early detection, awareness of the symptoms, and the risk factors that often lead to the development of diabetes.
