## **Shark Fin Trade Elimination Act of 2016**

This bill makes it illegal to possess, buy, sell, transport, or trade shark fins or any product containing shark fins. A person may possess a shark fin that was lawfully taken consistent with a license or permit under certain circumstances.

Penalties are imposed for violations under the Magnuson-Stevens Fishery Conservation and Management Act.

- **Jun 24, 2016:** Introduced in House
- **Jun 24, 2016:** Referred to the Committee on Natural Resources, and in addition to the Committees on Foreign Affairs, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
