## Summary (as of Nov 29, 2016)

### No Hero Left Untreated Act

(Sec. 3) This bill requires the Department of Veterans Affairs (VA) to carry out a one-year pilot program to provide access to magnetic EEG/EKG-guided resonance therapy to treat larger populations of veterans suffering from post-traumatic stress disorder, traumatic brain injury, military sexual trauma, chronic pain, or opiate addiction.

The VA shall carry out the program at up to two VA facilities and may provide access to such therapy to up to 50 veterans.
