Summary (as of Jun 24, 2015)

Constitutional Amendment

Prohibits construction of the Constitution as forbidding Congress or the states from: (1) imposing reasonable contentneutral limitations on private campaign contributions or independent election expenditures; or (2) enacting systems of public campaign financing, including those designed to restrict the influence of private wealth by offsetting campaign spending or independent expenditures with increased public funding.

- Jun 24, 2015: Introduced in House
- Jun 24, 2015: Referred to the House Committee on the Judiciary.
