Sets forth the rule for consideration of the bill (H.R. 3700) to provide housing opportunities in the United States through modernization of various housing programs.

Actions Timeline

- **Feb 2, 2016:** DEBATE - The House proceeded with one hour of debate on H. Res. 594.

Mr. Hastings demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until a time to be announced.

- **Feb 1, 2016:** Introduced in House
