## Summary (as of Nov 17, 2016)

(This measure has not been amended since it was introduced. The expanded summary of the House reported version is repeated here.)

### Midnight Rules Relief Act of 2016

(Sec. 2) This bill amends the Congressional Review Act to allow Congress to consider a joint resolution to disapprove multiple regulations that federal agencies have submitted for congressional review within the last 60 legislative days of a session of Congress during the final year of a President's term. Congress may disapprove a group of such regulations together (i.e., "en bloc") instead of the current procedure of considering only one regulation at a time.

- **Nov 17, 2016:** Considered under the provisions of rule H. Res. 921. (consideration: CR H6274-6283)

- **Nov 17, 2016:** House resolved itself into the Committee of the Whole House on the state of the Union pursuant to H. Res. 921 and Rule XVIII.
- **Nov 17, 2016:** The Speaker designated the Honorable Jeff Denham to act as Chairman of the Committee.
- **Nov 17, 2016:** GENERAL DEBATE - The Committee of the Whole proceeded with one hour of general debate on H.R. 5982.

- **Nov 17, 2016:** DEBATE - Pursuant to the provisions of H. Res. 921, the Committee of the Whole proceeded with 10 minutes of debate on the Jackson Lee Part B amendment No. 3.
- **Nov 17, 2016:** POSTPONED PROCEEDINGS - At the conclusion of debate on the Jackson Lee amendment No. 3, the Chair put the question on the amendment and by voice vote, announced that the noes had prevailed. Ms. Jackson Lee demanded a recorded vote and the Chair postponed further proceedings on agreeing to the amendment until a time to be announced.
- **Nov 17, 2016:** UNANIMOUS CONSENT REQUEST - Mr. Connolly asked unanimous consent to offer amendments numbered 4 and 5 printed in Part B of House Report 114-818 en bloc. Agreed to without objection.
- **Nov 17, 2016:** DEBATE - Pursuant to a previous order of the Committee, the Committee of the Whole proceeded with 10 minutes of debate on the Connolly amendments en bloc.
- **Nov 17, 2016:** POSTPONED PROCEEDINGS - At the conclusion of debate on the Connolly amendments en bloc, the Chair put the question on the amendments en bloc and by voice vote, announced that the noes had prevailed. The instructions contained in the motion seek to require the bill to be reported back to the House with an amendment to add an exemption to the end of bill for any rule that pertains to improving employment, retention, and earnings of workforce participants, especially those participants with significant barriers to employment, improving the quality of the workforce, and enhancing the productivity and competitiveness of the nation.

- **Nov 17, 2016:** On motion to recommit with instructions Failed by recorded vote: 181 - 239 (Roll no. 584).
- **Nov 17, 2016:** Passed/agreed to in House: On passage Passed by recorded vote: 240 - 179 (Roll no. 585).(text: CR H6278)
- **Nov 17, 2016:** On passage Passed by recorded vote: 240 - 179 (Roll no. 585). (text: CR H6278)
