### Summary (as of Dec 16, 2016)

(This measure has not been amended since it was passed by the House on September 21, 2016. The summary of that version is repeated here.)

(Sec. 1) This bill authorizes the Federal Aviation Administration (FAA) to enter into a reimbursable agreement with a state or local government agency for airport construction or alteration projects requiring notice to the FAA, if the agreement:

- includes cost-effective completion measures for such projects, and
- would not negatively affect the safety or efficiency of the national airspace system.
