National Veterans Memorial and Museum Act

This bill designates the Veterans Memorial and Museum currently being constructed in Columbus, Ohio, as the National Veterans Memorial and Museum.

Actions Timeline

- **Sep 20, 2016:** Referred to the Subcommittee on Federal Lands.
- **Sep 15, 2016:** Introduced in House
- **Sep 15, 2016:** Referred to the Committee on Veterans' Affairs, and in addition to the Committee on Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Sep 15, 2016:** Referred to the Subcommittee on Disability Assistance and Memorial Affairs.
