IDENT Fingerprint Digitization Completion Act of 2016

This bill requires U.S. Immigration and Customs Enforcement, within 90 days after this bill's enactment, to complete the digitization of all remaining paper-based fingerprint records for inclusion in the Automated Biometric Identification System (IDENT) of the Department of Homeland Security.

Actions Timeline

- **Sep 30, 2016:** Referred to the Subcommittee on Immigration and Border Security.
- **Sep 28, 2016:** Referred to the Subcommittee on Cybersecurity, Infrastructure Protection, and Security Technologies.
- **Sep 20, 2016:** Introduced in House
- **Sep 20, 2016:** Referred to the Committee on Homeland Security, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
