States that Congress does not favor the nuclear agreement with Iran (Joint Comprehensive Plan of Action) transmitted by the President to Congress on July 19, 2015, for purposes of prohibiting the taking of any action involving statutory sanctions relief by the United States pursuant to such agreement.

- Aug 4, 2015: Introduced in House
- Aug 4, 2015: Referred to the Committee on Foreign Affairs, and in addition to the Committees on Financial Services, the Judiciary, Oversight and Government Reform, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
