- **Apr 26, 2016:** Rule provides for consideration of H.R. 4498 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be considered read. A specified amendment is in order.
- **Apr 26, 2016:** Placed on the House Calendar, Calendar No. 109.
