Summary (as of Jun 8, 2016)

Sets forth the rule for consideration of the bill (H.R. 5325) making appropriations for the Legislative Branch for the fiscal year ending September 30, 2017.

Actions Timeline

- **Jun 9, 2016:** The Chair recognized Mr. Woodall for the purpose of calling up a resolution.
- **Jun 9, 2016:** POINT OF ORDER - Prior to consideration of the measure, Mr. Castro (TX) raised a point of order against consideration of H. Res. 771 and the Chair recognized Mr. Castro and Mr. Woodall for up to 10 minutes each on the point of order. After debate, the Chair will put the question of consideration on the resolution as the statutory means of disposing of the point of order in the following form: "Will the House now consider the resolution?".
- **Jun 9, 2016:** On question of consideration of the resolution
- **Jun 9, 2016:** On motion to consider the resolution Agreed to by the Yeas and Nays: 231 - 170 (Roll no. 283).
- **Jun 9, 2016:** Considered as privileged matter. (consideration: CR H3586-3596)
- **Jun 9, 2016:** DEBATE - The House proceeded with one hour of debate on H. Res. 771.
- **Jun 9, 2016:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 771, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Hastings demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.
- **Jun 9, 2016:** Considered as unfinished business. (consideration: CR H3598-3600)
- **Jun 9, 2016:** On ordering the previous question Agreed to by the Yeas and Nays: 241 - 181 (Roll no. 285). (consideration: CR H3599)
- **Jun 9, 2016:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 237 - 182 (Roll no. 286).(text: CR H3586-3587)
- **Jun 9, 2016:** On agreeing to the resolution Agreed to by recorded vote: 237 - 182 (Roll no. 286). (text: CR H3586-3587)
- **Jun 9, 2016:** Motion to reconsider laid on the table Agreed to without objection.
- **Jun 8, 2016:** Introduced in House
- **Jun 8, 2016:** The House Committee on Rules reported an original measure, H. Rept. 114-611, by Mr. Woodall.
- **Jun 8, 2016:** The resolution makes in order only those further amendments printed in the report. Each amendment may be offered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, be debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, shall not be subject to a demand for division of the question in the House or Committee of the Whole. Secion 2 provides that during consideration of H.R. 5325, section 3304 of Senate Concurrent Resolution 11 shall not apply.
