## Summary (as of Feb 5, 2015)

### Protect Overnight Delivery Act

Repeals the service standards for market-dominant products implemented by the U.S. Postal Service (USPS) on January 5, 2015, and directs USPS to reinstate the service standards that were in effect on December 31, 2011.
