Mr. Polis demanded the yeas and nays, and the Chair postponed further proceedings on the question of ordering the previous question until a time to be announced.

Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be considered read. Bill is closed to amendments.
