### Summary (as of Feb 10, 2015)

#### Medicare Residential Care Coordination Act of 2015

Directs the Secretary of Health and Human Services to establish and implement a demonstration project under titles XVIII (Medicare) and XIX (Medicaid) of the Social Security Act to evaluate the use of capitated payments made to eligible continuing care retirement communities for residential care coordination programs.

### Actions Timeline

- **Feb 27, 2015:** Referred to the Subcommittee on Health.
- **Feb 13, 2015:** Referred to the Subcommittee on Health.
- **Feb 10, 2015:** Introduced in House
- **Feb 10, 2015:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
