## Summary (as of Apr 4, 2016)

### Advancing Research for Neurological Diseases Act of 2016

(Sec. 2) This bill amends the Public Health Service Act to authorize the Department of Health and Human Services (HHS) to improve the collection of epidemiological and surveillance data on neurological diseases and conditions. HHS may provide support to public or nonprofit entities for such purpose. Collected data must be made available for biomedical research.

### Actions Timeline

- **Apr 4, 2016:** Committee on Health, Education, Labor, and Pensions. Reported by Senator Alexander with an amendment in the nature of a substitute. Without written report.
- **Apr 4, 2016:** Placed on Senate Legislative Calendar under General Orders. Calendar No. 408.
- **Feb 9, 2016:** Committee on Health, Education, Labor, and Pensions. Ordered to be reported with an amendment in the nature of a substitute favorably.
- **Mar 24, 2015:** Introduced in Senate
