Sets forth the rule for consideration of the bill (H.R. 3590) to amend the Internal Revenue Code of 1986 to repeal the increase in the income threshold used in determining the deduction for medical care.

- **Sep 13, 2016:** DEBATE - The House proceeded with one hour of debate on H. Res. 858.
- **Sep 13, 2016:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 858, the Chair put the question on ordering the previous question on H.Res. 858 and by voice vote, announced the ayes had prevailed. Mr. Polis demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.
