Actions Timeline

- **Dec 1, 2016:** ORDER OF PROCEDURE - Mr. Harper asked unanimous consent that the question of adopting a motion to recommit on H.Res. 933 may be subject to postponement as though under clause 8 of rule 20. Agreed to without objection.
- **Dec 1, 2016:** By the direction of the Committee on House Administration, Mr. Harper asked for the immediate consideration of H.Res. 933. (consideration: CR H7086-7095)
- **Dec 1, 2016:** DEBATE - The House proceeded with one hour of debate on H. Res. 933.
- **Dec 1, 2016:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 933, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Brady (PA) demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until a time to be announced.
- **Dec 1, 2016:** Considered as unfinished business. (consideration: CR H7096-7097)
- **Dec 1, 2016:** On ordering the previous question Agreed to by the Yeas and Nays: 235 - 177 (Roll no. 594). (consideration: CR H7096)
- **Dec 1, 2016:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 234 - 181 (Roll no. 595). (text: CR H7086)
