Summary (as of Feb 13, 2015)

Protecting America's Sovereignty Act

Prohibits the President from entering into any free trade agreement or investment treaty with a foreign country or countries that grants foreign investors the right to access an international tribunal to seek cash damages from or injunctive relief against the U.S. government if such investors believe that U.S. actions are in breach of rights conferred on foreign investors in the agreement or treaty.

Actions Timeline

- **Feb 27, 2015:** Referred to the Subcommittee on Trade.
- **Feb 13, 2015:** Introduced in House
- **Feb 13, 2015:** Referred to the Committee on Ways and Means, and in addition to the Committee on Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
