Expresses opposition to the completion of Nord Stream II, the gas pipeline that would transport natural gas from Russia through the Baltic Sea to Germany.

Urges the President to support European energy security through a policy of diversification to lessen reliance on Russia.

Supports the imposition of sanctions with respect to Nord Stream II.
