Summary (as of Sep 5, 2018)

Sets forth the rule for consideration of the bill (H.R. 6691) to amend title 18, United States Code, to clarify the definition of "crime of violence", and for other purposes, and providing for consideration of motions to suspend the rules.

Actions Timeline

- **Sep 6, 2018:** Considered as privileged matter. (consideration: CR H7882-7885)
- **Sep 6, 2018:** DEBATE - The House proceeded with one hour of debate on H. Res. 1051.
- **Sep 6, 2018:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 1051, the Chair put the question on ordering the previous question, and by voice vote, announced that the ayes had prevailed. Mr. Hastings demanded the yeas and nays and the Chair postponed further proceedings until later in the legislative day.
- **Sep 6, 2018:** Considered as unfinished business. (consideration: CR H7885-7887)
- **Sep 6, 2018:** On ordering the previous question Agreed to by the Yeas and Nays: 224 - 181 (Roll no. 386). (CR H7886)
- **Sep 6, 2018:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 225 - 179 (Roll no. 387). (text: CR H7882)
- **Sep 6, 2018:** On agreeing to the resolution Agreed to by recorded vote: 225 - 179 (Roll no. 387). (text: CR H7882)
- **Sep 6, 2018:** Motion to reconsider laid on the table Agreed to without objection.
- **Sep 5, 2018:** Introduced in House
- **Sep 5, 2018:** The House Committee on Rules reported an original measure, H. Rept. 115-920, by Mr. Buck.
- **Sep 5, 2018:** Section 2 provides that at any time on the legislative day of September 13, 2018, it shall be in order for the Speaker to entertain motions that the House suspend the rules as though under clause 1 of rule XV.
- **Sep 5, 2018:** Placed on the House Calendar, Calendar No. 181.
