Fair Medicare Hospital Payments Act of 2017

This bill amends title XVIII (Medicare) of the Social Security Act to establish, with respect to hospitals not located in a frontier state, a floor on the area wage adjustment factor for hospital inpatient and outpatient services covered under Medicare. (Such a floor already applies with respect to hospitals located in frontier states.)

Actions Timeline

- **Mar 1, 2017:** Referred to the Subcommittee on Health.
- **Feb 17, 2017:** Referred to the Subcommittee on Health.
- **Feb 16, 2017:** Introduced in House
- **Feb 16, 2017:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
