Sets forth the rule for consideration of the joint resolution (H.J. Res. 66) disapproving the rule submitted by the Department of Labor relating to savings arrangements established by States for non-governmental employees, and providing for consideration of the joint resolution (H.J. Res. 67) disapproving the rule submitted by the Department of Labor relating to savings arrangements established by qualified State political subdivisions for non-governmental employees.

Actions Timeline

- **Feb 14, 2017:** Considered as privileged matter. (consideration: CR H1139-1145)
- **Feb 14, 2017:** DEBATE - The House proceeded with one hour of debate on H. Res. 116.
- **Feb 14, 2017:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 116, the Chair put the question on ordering the previous question and by voice vote announced that the ayes had prevailed. Mr. McGovern demanded the yeas and nays, and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.
- **Feb 14, 2017:** Considered as unfinished business. (consideration: CR H1152-1154)
- **Feb 14, 2017:** On ordering the previous question Agreed to by the Yeas and Nays: 227 - 188 (Roll no. 90). (consideration: CR H1152-1154)
- **Feb 14, 2017:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 227 - 188 (Roll no. 91). (text: CR H1139)
- **Feb 14, 2017:** On agreeing to the resolution Agreed to by recorded vote: 227 - 188 (Roll no. 91). (text: CR H1139)
- **Feb 14, 2017:** Motion to reconsider laid on the table Agreed to without objection.
- **Feb 13, 2017:** Introduced in House
- **Feb 13, 2017:** The House Committee on Rules reported an original measure, H. Rept. 115-11, by Mr. Byrne.
- **Feb 13, 2017:** Each joint resolution shall be considered as read. All points of order against provisions in each joint resolution are waived. The previous question shall be considered as ordered on each joint resolution without intervening motion except one hour of debate and one motion to recommit.
- **Feb 13, 2017:** Placed on the House Calendar, Calendar No. 11.
