### Summary (as of Feb 16, 2017)

#### United States Cadet Nurse Corps Equity Act

This bill deems as active military service for Department of Veterans Affairs purposes any service as a member of the United States Cadet Nurse Corps between July 1, 1943, and December 31, 1948 (qualified service).

The Department of Defense shall issue an honorable discharge within one year to each person whose qualified service warrants one.

Retroactive benefits shall not be paid to persons as a result of enactment of this bill.

### Actions Timeline

---

- **Mar 23, 2017:** Referred to the Subcommittee on Military Personnel.
- **Mar 3, 2017:** Referred to the Subcommittee on Disability Assistance and Memorial Affairs.
- **Feb 16, 2017:** Introduced in House
- **Feb 16, 2017:** Referred to the Committee on Veterans' Affairs, and in addition to the Committee on Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
