Veterans 2nd Amendment Protection Act

(Sec. 2) This bill prohibits, in any case arising out of the administration of laws and benefits by the Department of Veterans Affairs, any person who is mentally incapacitated, deemed mentally incompetent, or experiencing an extended loss of consciousness from being considered adjudicated as a mental defective for purposes of the right to receive or transport firearms without the order or finding of a judicial authority of competent jurisdiction that such person is a danger to himself or herself or others.

- **Mar 22, 2017:** Read the second time. Placed on Senate Legislative Calendar under General Orders. Calendar No. 21.
- **Mar 21, 2017:** Received in the Senate. Read the first time. Placed on Senate Legislative Calendar under Read the First Time.
- **Mar 16, 2017:** Considered under the provisions of rule H. Res. 198. (consideration: CR H2102-2114)
- **Mar 16, 2017:** DEBATE - The House proceeded with one hour of debate on H.R. 1181.
- **Mar 16, 2017:** The previous question was ordered pursuant to the rule.
- **Mar 16, 2017:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.R. 1181, the Chair put the question on passage of the bill and by voice vote, announced that the ayes had prevailed. Mr. Roe (TN) demanded the yeas and nays and the Chair postponed further proceedings on passage of H.R. 1181 until a time to be announced.
