Summary (as of Dec 19, 2018)

Waives a specified requirement of Rule XIII (Calendar and Committee Reports) to allow consideration of any resolution reported from the Committee on Rules through the legislative day of December 24, 2018, on the same day it is presented to the House.

Makes it in order at any time through the calendar day of December 23, 2018, for the Speaker to suspend the rules as though under Rule XV (Business in Order on Special Days).

Actions Timeline

- **Dec 20, 2018:** Considered as privileged matter. (consideration: CR H10343-10344)
- **Dec 20, 2018:** DEBATE - The House proceeded with one hour of debate on H. Res. 1181.
- **Dec 20, 2018:** The previous question was ordered without objection.
- **Dec 20, 2018:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 1181, the Chair put the question on agreeing to the resolution and by voice vote, announced that the ayes prevailed. Mr. McGovern demanded the yeas and nays and the Chair postponed further proceedings until later in the legislative day.
- **Dec 20, 2018:** Considered as unfinished business. (consideration: CR H10345-10346)
- **Dec 20, 2018:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 350 - 30 (Roll no. 447).(text: CR H10343)
- **Dec 20, 2018:** On agreeing to the resolution Agreed to by the Yeas and Nays: 350 - 30 (Roll no. 447). (text: CR H10343)
- **Dec 20, 2018:** Motion to reconsider laid on the table Agreed to without objection.
- **Dec 19, 2018:** Introduced in House
- **Dec 19, 2018:** The House Committee on Rules reported an original measure, H. Rept. 115-1085, by Mr. Sessions.
- **Dec 19, 2018:** Rule waives clause 6(a) of rule XIII against any resolution reported from the Rules Committee thorough the legislative day of December 24, 2018. The rule also provides that it shall be in order at any time through the calendar day of December 23, 2018, for the Speaker to entertain motions that the House suspend the rules.
- **Dec 19, 2018:** Placed on the House Calendar, Calendar No. 198.
