### Summary (as of Feb 28, 2017)

This bill amends the Multinational Species Conservation Funds Semipostal Stamp Act of 2010 by requiring the U.S. Postal Service to make the stamp available to the public for at least 10 years rather than 6 years.

The public must be given the choice of two stamps, one depicting an African elephant and another depicting a tiger.

## Actions Timeline

- **Mar 7, 2017:** Referred to the Subcommittee on Federal Lands.
- **Feb 28, 2017:** Introduced in House
- **Feb 28, 2017:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
