Summary (as of Feb 28, 2017)

CPI-E Act of 2017

This bill bases cost-of-living increases in benefits under the Civil Service Retirement System, the Federal Employees Retirement System, military retirement and survivor benefit programs, the Social Security old-age, survivors, or disability insurance benefit program, and other specified veterans benefits programs on increases in the Consumer Price Index for the elderly.

Actions Timeline

- **Mar 27, 2017:** Referred to the Subcommittee on Health.
- **Mar 23, 2017:** Referred to the Subcommittee on Military Personnel.
- **Mar 8, 2017:** Referred to the Subcommittee on Social Security.
- **Feb 28, 2017:** Introduced in House
- **Feb 28, 2017:** Referred to the Committee on Ways and Means, and in addition to the Committees on Veterans' Affairs, Oversight and Government Reform, and Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
