- 1775 Spring Creek Lane in Billings as the "Dr. Joseph Medicine Crow VA Clinic," and
- 1766 Majestic Lane in Billings as the "Benjamin Charles Steele VA Clinic."

Any local public display of the name of the Dr. Joseph Medicine Crow Department of Veterans Affairs Clinic carried out by the United States or through the use of federal funds shall include both the English name, Dr. Joseph Medicine Crow, and the Crow name, Dakaak Baako.
