### Prescription Drug Price Transparency Act

This bill adds certain transparency requirements for pharmacy benefits managers under Medicare, Medicare Advantage, TRICARE, and the Federal Employees Health Benefits Program.

- **Mar 17, 2017:** Referred to the Subcommittee on Health.
- **Mar 15, 2017:** Referred to the Subcommittee on Health.
- **Mar 2, 2017:** Introduced in House
- **Mar 2, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, Armed Services, and Oversight and Government Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
