Reaffirming DHS Commitment to Countering All Forms of Extremism

This bill prohibits the Department of Homeland Security (DHS) from changing the name of its Countering Violent Extremism Task Force.

DHS may not make grants to counter Islamist extremism in an aggregate amount of more than \$4 million in any fiscal year and shall ensure that any such grants made for a fiscal year are closely matched in aggregate dollar amounts in grants made to counter other forms of extremism for such fiscal year.

Actions Timeline

- **Mar 22, 2017:** Referred to the Subcommittee on Counterterrorism and Intelligence.
- **Mar 9, 2017:** Introduced in House
- **Mar 9, 2017:** Sponsor introductory remarks on measure. (CR H1957)
- **Mar 9, 2017:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations.
- **Mar 9, 2017:** Referred to the Committee on Homeland Security, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
