Summary (as of Mar 15, 2017)

Financial Transparency Act of 2017

This bill amends the Financial Stability Act of 2010, the Investment Advisers Act of 1940, the Federal Deposit Insurance Act, and other laws to require federal financial regulatory agencies to adopt specified data standards with respect to format, searchability, and transparency.

Actions Timeline

- **Mar 23, 2017:** Referred to the Subcommittee on Commodity Exchanges, Energy, and Credit.
- **Mar 15, 2017:** Introduced in House
- **Mar 15, 2017:** Referred to the Committee on Financial Services, and in addition to the Committee on Agriculture, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
